 - FOUR HVAC LOAD CALCULATIONS (Manual-J or equivalent)
 - FOUR AIR DISTRIBUTION SYSTEM SIZING CALCULATIONS (Manual-D or equivalent)
 - FOUR ENERGY CODE CALCULATIONS
 - FOUR PLOT PLANS for **Residential** / A COPY OF SITE PLAN for **Commercial**
 - Utilities served by: City of VB County Environmental Health (well/septic)
 - ALL COMMERCIAL – PROVIDE ONE COPY OF SOILS INVESTIGATION REPORT.**
Residential: All waterfront properties and any location of questionable soil such as Vero Isles, Cache Cay, Moorings #5 -The anchor, Riverboat Club, Kingswood Estates, and Savannah Oaks or other areas of questionable soils.
1. **Plans must be complete. Plans must be stapled. No loose sheets.**
 2. **No Applications will be accepted without payment of the Permit Application Fee.**
 3. **ONLY A PLANS EXAMINER CAN APPROVE DEVIATIONS FROM THE ABOVE REQUIREMENT ON A CASE-BY-CASE BASIS. NO EXCEPTIONS!**
